BARRIERS TO ENTRY INTO THE FIELD

LACK OF SOCIAL CAPITAL

When we think about Social Capital, questions come up like, "Well I'd like to get into counseling but where do I start? or "No one in my family has ever done anything like this before." As a participant in the CALPCC Fellows program, BIPOC students will have a chance to network with other BIPOC members in the field to connect, to learn, and to grow.

COMMUNITY STIGMA

In communities of color, there is inherent stigma related to mental health and as a career choice. With continued exposure to the field, students will be able to bring a new perspective of mental health and its benefits back to their communities. Also, it is important that clients see counselors that look like them.





EDUCATION EXPENSE

Let's face it. Education is expensive. Without the privilege of help from family, an inability to save for higher education, not having exposure to scholarship guidance, and a host of other factors, educational expense can keep BIPOC students from attaining education post undergraduate degree. This program will help students understand this barrier and how to mititgate some of the costs of graduate school.

TRAINING AND LICENSING

Considering the time investment on the path through education and licensing, fees for licensing, licensing exams, continuing education credits, books, other fees, and the foregeone cost of not being able to work full time, students constantly are facing an uphill climb on the path to becoming a counselor. While we cannot get around licensing requirements, paving that pathway makes it a heck of a lot easier.

CONSTANT OPPORTUNITY COST ANALYSIS

"Do I buy my books this semester or feed my family and just borrow my friend's book?" "I know I need to earn my 3000 hours, but I also need to work full time. How long is this going to take me to finish?" These are common questions BIPOC students ask. They should not have to choose between higher education and taking care of their families. Let's get to work on this.

STUDENTS SELECTED FOR THIS PROGRAM WILL:

- Have access to Board of Directors for career guidance and mentorship
- Participate in a 1 year long fellowship program
- Receive a two-year Student level membership to CALPCC.
- Participate in monthly programming as outlined below.

- Receive complimentary registration at all CALPCC Sponsored events
- Receive membership in Regional Networking Groups
- \$500 Fee Scholarship upon acceptance to a counseling graduate program to cover Application fees, books, test prep, licensing fees, test fees, technology, etc.

PROGRAM REQUIREMENTS

STUDENTS MUST:

- Applicant must be a member of the one or several of the following communities: BIPOC, LGBTQ+, foster youth, and/or have a physical or other disability.
- Be enrolled at a qualified undergraduate institution
- Be enrolled in a Bachelor's level program studying Psychology, Sociology, Criminal Justice, or Education.
- Be willing to commit to (1) 1.5 Hour Meeting 1-2 times per month via Zoom with no more than 2 absences over the 12 months of the program.
- Be willing to participate in monthly discussions and remain engaged.
- Be recommended by a College Counselor, Academic Advisor, Professor, Employer, or parent by letter of recommendation.
- Submit one page letter of intent that speaks to a) your interest in the program, b) your experience with mental health, c) your career aspirations.
- Please submit along with Resume/CV



When does this program start?

Planned launch date is 12/1/20. We will start taking applications on that date.
