Understanding LPCCs In California

Who Are LPCC's?

Licensed Professional Clinical Counselors
Business and Professions Code 4999.20

- More than 144,000 licensed professional counselors in 50 states
- Provide mental health care to millions of Americans
- Make up a large percentage of the workforce employed in mental health centers, agencies, and organizations
- Are reimbursed by managed care organizations and health plans
- The LPCC license is on par with LMFT and LCSW licenses.

How Are LPCCs Governed?

The California Board of Behavioral Sciences (BBS) regulates LPCCs, LMFTs, LCSWs, and LEPs

Where and With Whom do LPCCs Work?

- Individuals, families., groups, and communities
- Active duty military personnel and their families, as well as veterans (DoDs, TRICARE, VA)
- Can be employed in mental health centers, agencies, and organizations
- Treat mental, behavioral, and emotional problems and disorders

Once Licensed What Can LPCC's Provide?

Supervision of APCCs and AMFTs
(with additional training) earning the 3,000
post-degree hours & Supervision of ASWs
